Minutes from LPCA Meeting Wednesday, October 12, 2022

Co-Presidents Kathleen McSweeney and Thora Colot opened the meeting at 7:30 pm. Kathleen thanked Thora for her hard work this past year as she is moving out of Lyon Park.

John Goldener, chair of the nominating committee, walked through the procedures for the election (as noted below.)

Five nominees were put forth for four slots on the Board of Governors. Each nominee gave a 30 second introduction and voting commenced.

While votes were tallied, the meeting transitioned to discussion of the Days Inn site development plan, presented by Shooshan Development.

Days Inn Site (ARVA Project)

Membership - Natalie Roy

Developer is planning a mixed-use building. 251 units, adding/upgrading public park. Parking provided for .8 cars per unit. They acknowledged the need to avoid adding traffic to neighborhood streets.

Stylistically they are building on the original feel of the 1950's Arva Motel. Plans call for a step down building, 7+ stories on Rt 50 and 6 stories on Pershing, with 2 story heading into the neighborhood.

Public access park on corner of Pershing and Wayne is still in the planning stage.

The final project is expected to include 40% 1BR units, 30% 2BR units, with remaining 30% studios. Currently it is not family focused. There may be an opportunity to add larger units.

Units will all be rentals. The question was asked whether there is enough parking. If not, it will negatively impact neighborhood as tenants park in surrounding residential neighborhoods.

In an update from the last meeting, some of the historical elements cannot be preserved but will be replicated in some way.

The proposal has been filed, and more input will be solicited going forward (starting in November maybe.)

Election wrap-up:

As there are 5 seats available (4 elected and one assigned by the LPCA president), all 5 candidates will serve as the BOG representatives for the next year.
